Enclosed for filing in the above-referenced dockets are the New York Independent System Operator, Inc.'s ("NYISO") Semi-Annual Reports to the Federal Energy Regulatory Commission ("Commission") on the NYISO's New Generation Projects and Demand Response programs in the New York Control Area. This filing is made for informational purposes only in accordance with the Commission's delegated order issued February 23, 2010 in these dockets.<sup>1</sup>

**I. Documents Submitted**

3. Confidential Exhibit A to the NYISO Semi-Annual Compliance Report on Demand Response Programs, May 30, 2019 – CONFIDENTIAL (unredacted) (“Confidential Exhibit A”) (“Attachment III”).

## **II. Request for Confidential Treatment of Confidential Exhibit A to the NYISO Semi-Annual Compliance Report on Demand Response Programs**

The attached Semi-Annual Compliance Report on Demand Response Programs (“Demand Response Report,” filing Attachment II) summarizes the current status of demand response participation in the NYISO’s markets as of May 2019. The Demand Response Report redacts confidential, commercially sensitive information in Table 2, and omits Tables 4 and 5 in their entirety. The confidential, unredacted versions of Table 2, as well as the entirety of Tables 4 and 5 are in Confidential Exhibit A (Attachment III), which is labeled as confidential and is being filed separately.

In accordance with Sections 388.107 and 388.112 of the Commission’s regulations,<sup>2</sup> Article 6 of the NYISO’s Market Administration and Control Area Services Tariff, and Sections 1.0(4) and 4.0 of the NYISO’s Code of Conduct,<sup>3</sup> the NYISO requests Privileged and Confidential treatment of the contents of Confidential Exhibit A. The NYISO also requests that the Confidential Exhibit A be exempted from public disclosure under the Freedom of Information Act (“FOIA”), 5 U.S.C. § 522.<sup>4</sup>

Confidential Exhibit A contains commercially sensitive, trade secret information that is not made public by the NYISO. Disclosure of such information could cause competitive harm to the affected Market Participants,<sup>5</sup> and could adversely affect competition in the markets administered by the NYISO. This information includes a very limited number of demand response Resources in certain Load Zones. Confidential Exhibit A also contains information on NYISO’s Demand Side Ancillary Services Program, and total enrollment for the entire program is very limited. With such a small number of Resources participating in the program, the aggregation of the data reported would not sufficiently mask confidential and commercially sensitive Market Participant Information. Further, because this confidential, commercially sensitive information is exempt from disclosure under 5 U.S.C. § 522(b)(4), the NYISO requests that the contents of Confidential Exhibit A receive Privileged and Confidential treatment and be exempt from FOIA disclosure. Confidential Exhibit A is identified and marked in accordance

# Attachment I

## ATTACHMENT I

### **NYISO May 30, 2019 Report on New Generation Projects**

In an October 23, 2006 order, the Commission ordered the NYISO to submit “a list of investments in new generation projects in New York (including a description and current status of each such project), regardless of the stage of project development at the time of the filing.”<sup>1</sup> The NYISO keeps a list of Interconnection Requests, load projects and Transmission Projects for the New York Control Area that includes information about all generation projects in the State that have requested interconnection (“NYISO Interconnection Queue”).

The NYISO interconnection process for generators<sup>2</sup> is described in two attachments of the NYISO Open Access Transmission Tariff: Attachment X entitled, “Standard Large Facility Interconnection Procedures,” and Attachment Z entitled, “Small Generator Interconnection Procedures.” Attachment X applies to Generating Facilities that exceed 20 MW in size and to Class Year Transmission Facilities, collectively referred to as “Large Facilities.” Attachment Z applies to Generating Facilities no larger than 20 MW.

Under Attachment X, Developers of Large Facilities must submit an Interconnection Request to the NYISO. The NYISO assigns a Queue Position to all valid Interconnection Requests. Under Attachment X, proposed Large Facilities undergo up to three studies: the Optional Feasibility Study, the System Reliability Impact Study, and the Class Year Interconnection Facilities Study. The Class Year Interconnection Facilities Study is performed on a Class Year basis for a group of eligible projects pursuant to the requirements of Attachment S of the NYISO OATT. Under Attachment Z, proposed small generators undergo a process that is similar, but with different paths and options that are dependent on the specific circumstances of the project.

Proposed generation, load and transmission projects currently in the NYISO interconnection process are listed on the list of NYISO Interconnection Queue. The generation projects on that list are shown in Exhibit A to this Attachment I, which is dated April 30, 2019. The NYISO updates its Interconnection Queue on at least a monthly basis and posts the most recent list on the NYISO’s public web site at <https://www.nyiso.com/interconnections> (in the “Interconnection Projects/NYISO Interconnection Queue” section).

The status of each project on the NYISO Interconnection Queue is shown in the column labeled “S.” An explanation of this column is provided in Exhibit B to this Attachment I. Also, note that the proposed In-Service Date or Commercial Operation Date for each project is the date provided to the NYISO by the respective Owner/Developer, is updated only on a periodic basis, and is subject to change.

**Semi-Annual Compliance Report on Demand Response Programs  
May 30, 2019**

This report summarizes the status of demand response participation in the New York Independent System Operator Inc.'s ("NYISO's") markets as of the Installed Capacity ("ICAP") auction month of May 2019. As in previous years, this report focuses on enrolled demand response participation in preparation for the Summer Capability Period.<sup>1</sup> An overview of the status of the NYISO's several demand response initiatives is provided below.

Deployments of the NYISO's two reliability-based programs (the Emergency Demand Response Program ("EDRP") and the Installed Capacity – Special Case Resource program ("ICAP/SCR")) during the Summer 2018 Capability Period were reported in the NYISO's 2018 Annual Report on Demand Response Programs submitted on January 15, 2019 ("January 2019 Report").<sup>2</sup>

The NYISO also has two economic programs (the Day-Ahead Demand Response Program ("DADRP") and the Demand-Side Ancillary Services Program ("DSASP")). DADRP enrollment has been static for several years and enrolled resources have not participated in the energy market for more than four years. Given the lack of activity during the analysis period, there is no market participation to report.

### **Demand Response Enrollment**

This report presents statistical data on demand response enrollment. Demand response providers include individual retail electricity consumers that participate directly in the NYISO's market as a Customer, as well as curtailment service providers, which is a general term used to identify the NYISO Customers that represent retail customers in the NYISO's demand response programs.<sup>3</sup>

- Aggregator - an entity that enrolls individual retail electricity consumers within the same Load Zone that may be aggregated to form a single demand response resource;
- Competitive Load Serving Entity<sup>5</sup> (“LSE”) - an entity authorized to supply Energy, Capacity and/or Ancillary Services to retail customers located within the New York Control Area (“NYCA”);
- Transmission Owner<sup>6</sup>/LSE - the public utility or authority that owns facilities used for the transmission of Energy in interstate commerce and provides Transmission Service under the Services Tariff.

Since the NYISO’s 2018 Semi-Annual Demand Response Report (“June 2018 Report”),<sup>7</sup> the number of curtailment service providers participating in the NYISO’s demand response programs has decreased by three.

Tables 2 and 3 present enrollment statistics by Load Zone for EDRP and ICAP/SCR respectively. Each table presents the total number of resources, total MW enrolled, and the enrolled MW of eligible Local Generators, or other behind-the-meter supply sources, facilitating

load reduction. In addition, changes in the number of resources and enrolled MW since the June 2018 Report are shown by Load Zone.

Table 2 shows EDRP Enrollment and ICAP Unsold. Of the 56 end-use locations, 50 participated in the EDRP program and six were ICAP/SCRs with unsold capacity.<sup>8</sup> Enrolled EDRP MW and ICAP Unsold increased 802.1% and end-use locations increased 36.6% since the June 2018 Report. The largest increase in enrolled MW and in end-use locations occurred in Load Zone J (NYC).

Table 3 reflects ICAP/SCR MW sold in the May 2019 ICAP Spot Market Auction (May is the first month of the Summer Capability Period). Historical data shows that enrollment in the ICAP/SCR program changes monthly throughout the Summer Capability Period. The data shows ICAP/SCR enrolled MW decreased 4.4% compared with the same period reported in the June 2018 Report and the number of end-use locations decreased 3.7%.

During the analysis period of November 2018 through April 2019, there were three Demand Side Resources actively participating in the DSASP as providers of Operating Reserves. The resources represented 116.5 MW of capability and had an average performance of 0.0% during this analysis period.

Tables 4 and 5, not presented in this public report, describe enrollment in the DSASP. Due to the limited participation in this program, those tables are provided only in Confidential Exhibit A.

**Update on 2019 Demand Response Initiatives**

This section provides an update on the status of initiatives that the NYISO has been working on with its stakeholders to improve the administration of its demand response programs and to address regulatory directives to facilitate market participation. In particular, the NYISO has focused on:

- Continued Development of the Demand Response Information System (“DRIS”);
- Enhancing Demand Response in the Real-Time Energy Market by developing a Distributed Energy Resource participation model

**Continued Development of the Demand Response Information System**

The NYISO successfully deployed software improvements to DRIS in Q1 2019. These deployments enhanced the user experience for NYISO Market Participants by streamlining the submission of certain resource enrollment documentation.

Demand Response in the Real-Time Energy Market via the NYISO’s Distributed Energy Resources Roadmap for New York’s Wholesale Electricity Markets

The NYISO initiated a project in 2016 to integrate Distributed Energy Resources (“DER”), including demand response, into its real-time Energy markets. The primary outcome of this initiative will be the integration of dispatchable DER in the NYISO’s Energy, Ancillary Service and Capacity markets.<sup>9</sup> In 2017 the NYISO published a DER Roadmap<sup>10</sup> describing NYISO’s vision for integrating these resources into the wholesale markets, and proposed a market design concept and tariff revisions in 2018.<sup>11</sup> On April 24, 2019 the DER market design received an affirmative vote from the NYISO Management Committee. The NYISO will submit its proposed tariff revisions to the Commission, and continue the work necessary to implement the DER market design in 2019.
