New York Transco LLC (“NY Transco”) hereby submits for filing for informational purposes the Annual Update and True-Up Adjustment to NY Transco’s formula rate for Rate Year 2018, in accordance with Sections 2 and 3 of the Formula Rate Implementation Protocols (“Protocols”) set forth in Section 36.3.1.2 (Attachment DD) of the New York Independent System Operator, Inc.’s (“NYISO”) Open Access Transmission Tariff. The Annual Update reflects NY Transco’s 2018 actual Net Adjusted Revenue Requirement based on its actual costs as reported to the Federal Energy Regulatory Commission in NY Transco’s FERC Form No. 1 filing.

<sup>1</sup> On May 8, 2019, NY Transco filed revisions to its formula rate to comply with the provisions of the August 21, 2017, settlement agreement regarding cost recovery of the AC Transmission Projects due to the fact that NY Transco was selected by the NYISO to develop Segment B of project portfolio. That filing is currently pending before the Commission so the formula rate included in Attachment A reflects the currently effective formula rate and is consistent with the version utilized by NY Transco when it presented its annual projection in the Fall 2017.
