Regulatory Proceedings

- The metering service complaint proceeding (Docket No. EL18-188) remains under review by FERC
 - NYISO sought to hold the proceeding in abeyance until it submitted the MSE tariff revisions as part of its DER and Aggregation tariff filing
- The NYISO's DER and Aggregation tariff filing (Docket No. ER19-2276) sought FERC acceptance of the tariff revisions by August 26, 2019
 - The Commission has not yet issued an Order accepting those revisions
 - Commission staff issued a deficiency letter on August 23, 2019 seeking further information on certain NYISO proposals; NYISO's response is due by September 23, 2019
- In order to proceed with the planned MSE implementation date of November 1, 2019, the NYISO needs FERC acceptance of the filed tariff revisions by mid-September
 - Will allow NYISO to proceed with an orderly transition recognizing the SCR enrollment periods and certification requirements
- The remainder of this presentation assumes FERC acceptance of the MSE tariff revisions by mid-September

Meter Services Entity Technical Bulletin

- Will be published in September 2019, prior to the opening the November 2019 SCR/EDRP Enrollment Period
- Contains the requirements for MSE authorization and operation to provide physical metering and meter data services for an MP
 - MSE construct replaces the existing MDSP/MSP construct for providing meter data for EDRP and SCR programs

MSE * 1 2010

- For any hour beginning prior to HB00 on Operating Day November 1, 2019
 - Meter data from MSP/MDSP as specified in TB-247 or from the TO is acceptable
- Beginning at HB00 on Operating Day November 1, 2019
 - Meter data from MSE or TO will be accepted
 - Any data submitted from an MSP/MDSP that has not become an MSE will not be accepted

MSE 60-Day Transitional Period

- The NYISO will start officially accepting MSE applications on November 1, 2019
 - The registration review process is intended to take 30 days once the NYISO has received the completed MSE Registration Packet and the application fee
- The 60-Day Transitional Period will:
 - Begin on November 1, 2019
 - End on December 30, 2019
- Allows Market Participants to enroll SCR/EDRP resources, while the entity it intends to use as the provider of meter data works through the MSE application and NYISO approval process
 - While the application process is under NYISO review, the entity must operate to satisfy the MSE Technical Bulletin requirements
- If the MSE fails to successfully complete the application process, the MP will be liable for any penalties that may be incurred due to lack of qualified meter data
 - This would include scenarios such as an MSE installed meter that does not comply with the NYISO requirements
